Dear Sir or Madam:

Under Section 552, Texas Government Code, I am requesting copies of all publicly releasable records associated with your department's arrest of Ms. Carey Mae Parker on Feb. 21, 1991. Please include the original Offense Report, Investigative File, Crime Scene Photo/s, 911 Call Sheet, and 911 Audio and Service Desk Audio, if transferred.

Ms. Parker's Social Security number is [REDACTED]. Her Driver's License number at the time was [REDACTED]. Her birthdate is May 12, 1967.

The charges were filed into your system as "FTMFR/FTCS/OMV". The arresting officer was "FOUST". The place of offense is listed as "E-Z MART."

If there are any fees for searching or copying these records, please inform me if the cost will exceed \$25. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of government operations and activities. I am a representative of the news media, and this request is related to news-gathering purposes for dissemination to the general public. This information is not being sought for commercial purposes.


